## ROOM AGREEMENT

Effective [August] 2021

### 1. Definitions

- A. In this Agreement, the words “YOU” and “YOUR” mean all persons who sign this Agreement as Residents.
- B. In this Agreement, “WE” and “US” mean Shinshu Kyokai Mission Dormitory.

### 2. Period of Agreement

- A. The period of this Agreement begins and ends according to the paid period on your last payment receipt.

#### Period of Stay:

Rental period may be extended with a new contract based on room availability.

- B. Arrival time: You may move in at **1:00 P.M.** but no later than **5:00 P.M.**
- C. Departure: You must vacate your room by **12:00 NOON.**

### 3. Cancellation Policy

**Canceling a reservation or departing earlier than the specified departure date will result in a charge of \$500.00.** Shinshu Kyokai Mission Dormitory reserves the right to cancel the Room Agreement (see page 3).

### 4. Room Costs and Charges

- A. Room Rate: The minimum stay is 1 week = **\$250.00**

**There is no daily rate.** Residents are charged on a weekly or monthly basis. One week is 7 days. A stay of 8 days will be charged for two weeks (\$500), a stay of 15 days for three weeks, etc.

Monthly rate = **\$730.00** \*see page 2

A Security Deposit of **\$700.00** is required for a stay longer than 1 week.

**Absolutely NO refunds will be made for early departure. Room rates are subject to change without notice.**

**Your payment is due in advance** no later than the end of the period on your last receipt.

Any amount unpaid by this date will be subject to a penalty charge of 5 percent. If the payment date occurs on a Saturday, Sunday or holiday, you hold responsibility to pay earlier.

Check-in: The first rent and Security Deposit must be paid in full if arriving after office hours.

#### 4. Room Costs and Charges (continued)

A\* Monthly rate of **\$700.00** is offered for a stay of 6 months or longer.

##### B. Security Deposit

**In addition to the room payment, a one-time payment is required as a Security Deposit.** The Security Deposit will be **\$250.00** for a one-week stay, or **\$700.00** for a stay longer than two weeks.

Your Security Deposit, minus any deductions, will be sent within fourteen (14) working days after the day you check out from the Dormitory. You must address an envelope to yourself (your home or next mailing address), supply sufficient postage, and bring this envelope to the office.

Deductions may be made for these reasons:

1. To repair or replace any items damaged or missing.
2. To restore the room to a clean and neat condition.
3. Storage charges for your personal belongings left on the premises.
4. Any other monies owed to us.

**Note: All applicable refunds will be returned upon receipt of your postage-stamped, self-addressed envelope.**

##### C. Rooms with Lanai

Residents in a balcony room will be charged an additional **\$15.00** per week or **\$60.00** per month.

##### D. Parking

The lot gates are locked each night at 10 P.M. and opened each morning at 6. For Residents, a stall is **\$2.50** per day, **\$15** per week, or **\$50** for a month.

**Note: NO parking refunds will be made for early departure or upon cancellation of this Agreement.**

##### E. Linen

A set of clean linens (1 pillow case, 2 bed sheets) will be provided. You are responsible for laundering the linens on a regular basis and for returning them when you leave the dormitory.

##### F. Kitchen Use

You must be a resident at Shinshu Kyokai Dormitory in order to use the kitchen facility. Guests and visitors are welcome in the dining area but are prohibited from entering the kitchen. Residents who use the kitchen do so at their own risk. Kitchen users are expected to abide by the kitchen rules.

## 5. Rules and Regulations

The **Rules and Regulations** of the dormitory (a copy will be provided upon check-in) are part of this Agreement. By your execution of this Agreement you acknowledge receipt of a copy of the **Rules and Regulations Handbook** and you agree to and will abide by the **Rules and Regulations** and any amendments thereto which may be posted on the dormitory bulletin board.

## 6. Cancellation of the Agreement by Us

We may terminate or cancel this Agreement if you do not abide by the **Rules and Regulations** of the dormitory or if you breach this Agreement.

We reserve the right to keep all or any portion of payments made by you, as damages resulting from your failure to abide by the **Rules and Regulations** or for breaching this Agreement.

## 7. Residents must be Students

You must be registered as a full- or part-time student or enrolled in a post-secondary educational program directed by an area school, college or university. A copy of your current registration must be filed with US upon request.

## 8. Non-assignment of this Agreement by You

You may not assign this Agreement under any circumstances.

## 9. Binding effect of Agreement

This Agreement is binding and effective only when it is executed by US. Once executed, WE will provide services under this Agreement only to you and to no other person.

## 10. Payment of cost and fee upon default or breach of this Agreement by You

If you default or breach any of the provisions of this Agreement, you shall pay all reasonable sums expended by US to enforce this Agreement (including court costs, collection and/or attorney's fees and costs).

## 11. Separability of Provisions

If any of the provisions of this Agreement are held to be invalid or unenforceable, those provisions will not affect the validity or enforceability of the remaining provisions. The undersigned hereby agrees to comply with all provisions of the **Room and Board Agreement**, and s/he understands that s/he is financially responsible as outlined above.
